# Howland Local Schools Community Survey - 2011

## Introduction

In total, 790 registered voters and stakeholders were interviewed about the Howland School District.

- 450 registered voters from the Howland school district were randomly selected and telephone interviewed about the schools during February and March of 2011; the margin of error for the survey results from this segment is  $\pm 4.5\%$ .
- 340 stakeholders including teachers, parents and employees throughout the school district completed and returned paper surveys. The stakeholders included 145 teachers, 136 parents, and 59 school district employees. Among the 340 stakeholders who returned paper surveys, 213 are registered voters living in the Howland School District.

The survey results have been divided into the following groups to better understand the data and are shown on the data tables that follow:

- Registered Voters – survey results were computed for two groups of registered voters in the district: 450 voters were randomly selected from the school district and telephone interviewed; in addition, 213 stakeholders were voters in the district who returned paper surveys including 51 teachers, 120 parents and 42 employees.
- Past Levy Supporter – 500 of the voters surveyed have voted for most of the tax levies in the past, while 146 have not.
- School Influencers – 145 teachers, 346 parent/grandparents of Howland students, and 206 school alumni were interviewed.
- Length of Residency – 75 residents have lived in the district less than 6 years, 100 residents have lived in the district for 6 to 10 years, and 503 have lived in the district over 10 years.
- College Graduate – 475 of the residents interviewed are college graduates, while 302 have not graduated from college.
- Respondent Age – 672 of the residents interviewed are under 65 years of age, while 106 of the residents are 65+ years of age.
- Support Taxes – 439 of those interviewed would support an operating levy and 417 would support taxes for a school auditorium.
