NEW STUDENT REGISTRATION

Registration for new students who have moved into the Howland Local School District is held daily at the administration offices, 8200 South St. SE. In order for your child's registration to be complete, please be sure to **bring the following information with you:**

- A certified copy of the child's birth certificate.
- Child's social security card.
- Child's immunization record.
- Your **driver's license plus two (2)** proofs of residency, showing **your name and Howland address** (such as utility bill, lease, tax statement, mortgage statement, insurance statement, etc).
- Proof of custody (if applicable). Court document, date stamped, which indicates custodial parent.
- Copy of current IEP if the child is in special education classes.
- Copy of latest report card (**must have for middle school and high school students**)
