



# **HHS Progression of Discipline**

**(Student Code of Conduct Addendum 2018-2019)**

## ***Detentions, Suspensions, and Expulsions:***

Suspension and/or expulsion from school may be used at the discretion of school administration (Head Principal, Assistant Principal, or the Superintendent) for a violation of any rules or regulations relative to student conduct or actions detrimental to the learning process.

While it is legal for school administration in the state of Ohio to suspend a student up to a total of ten (10) school days; only the Superintendent has the authority to expel a student from school for a period of up to ninety (90) days, the remainder of the school year, into the next school year, or a full year for possession of weapons or drugs.

Rules and expectations outlined or implied in the HLS Student Code of Conduct apply to actions while on school premises, at school functions off premises, on school transportation, as well as physical, written, verbal, or electronic conduct conducted off school premises which directly impacts other students, the school, or HHS staff.

Student discipline can be either minor or major, formal or informal, depending upon the severity and/or repetitiveness of the conduct violations.

**Student code of conduct violations are cumulative in nature and will be dealt with accordingly. As part of the defined progression of discipline, student conduct violations that reveal a repetitive pattern of behavior will result in more severe disciplinary action taken by school administration.**

- 1st Offense- 3 Detentions (or Lunch Detentions)and / or Behavior Contract / Plan and/or SMART and/or One (1) Day out-of-school suspension with probation of extracurricular and/or privilege*
- 2nd Offense- Three (3) days of out-of-school suspension with the forfeiture of extracurricular and/or privilege for length of time.*
- 3rd Offense- Five (5) days to Ten (10) days of out-of-school suspension with the possibility of a recommendation for expulsion / alternative school placement.*

### *LEVEL THREE VIOLATIONS:*

1. \_\_\_\_\_ Fighting -
  - i. **First Offense** -Five (5) Days out-of-school suspension
  - ii. **Second Offense** -Ten (10) Days out-of-school suspension with the recommendation for expulsion, also charges may be filed with the Howland Police Department. Consequences depend on the severity of the altercation as well as the condition of the safety of the rest of the student body and staff.

## HHS Progression of Discipline - LEVEL FOUR VIOLATIONS



*1st Offense- Ten (10) days of out-of-school suspension with the forfeiture of extracurricular and/or privilege indefinitely and recommendation for expulsion / alternative school placement.*

**NOTE:** ANY VIOLATION OF ANY PART OF HLS CODE OF CONDUCT MAY RESULT IN DISCIPLINARY ACTION UP TO AND INCLUDING EXPULSION. IN ADDITION, STUDENTS MAY ALSO BE REQUIRED TO UNDERGO A MENTAL HEALTH EVALUATION, ADMINISTERED BY A LICENSED MENTAL HEALTH PROVIDER, PRIOR TO RETURNING TO SCHOOL. SAID REQUIREMENTS ARE AT THE DISCRETION OF BUILDING LEVEL AND/OR DISTRICT LEVEL SCHOOL ADMINISTRATION.
